



The Green Valley Pool Rules

The following are general rules and guidelines (the "Pool Rules") that govern the safe operation of the Green Valley Pool ("the "Pool"). A copy of the Pool Rules is kept in the binder at the front gate. We do not wish the Pool Staff to serve as policemen. Your cooperation with respect to obtaining a proper membership, identifying all of your Guests, and obeying the Pool Rules will be greatly appreciated.

Use of the Pool (the gated confines and the parking lot) is intended solely for Members and their Guests. The Pool is not open to the public. By meeting the required prerequisites, families can become Members of the Pool for the current season. All of the following prerequisites for seasonal Membership must be on file with the Pool:

- (1) a complete Membership form listing all required current information,
- (2) Complete and signed copies of the "Pool Rules" and the "Green Valley Park and Recreation District Release and Assumption of Risk Agreement and Authorization for Emergency Treatment and Transportation" forms, and
- (3) proof of payment in full.

A "Family" Membership is intended only for the immediate family members of the permanent household, and does not include any person of a Member's 'extended' family. A "Senior" Membership is intended only for those households where all immediate family members of the permanent household are aged 55 or older. Use of a Senior Membership by a non-Senior family will require full payment of a Family Membership for use of the Pool. All persons who are not Members are considered Guests, including anyone who is watching the children of a Member-family in the absence of the parents, and are permitted to stay only while accompanied by the Member.

All Members and their Guests must sign in at the front gate for each visit. By signing in, Members and their Guests agree to obey the direction of Pool Staff and to abide by the Pool Rules. Guests are the complete responsibility of the Member. Members are limited to a maximum of five (5) Guests a day. Guests are required to pay a usage fee and to provide emergency contact information at the time of their arrival. Anyone who is not a Member or a Guest is required to leave the Pool.

The Pool is open only when a Lifeguard, employed by the Pool, is on duty. Pool hours of operation are listed at the Pool and on our web site. Pool hours may be adjusted at the discretion of the Pool Staff or the Board of Directors. Access to the Pool may be denied to any and all persons: (1) at the Lifeguard's discretion, (2) if unsafe conditions exist, or (3) if the outside temperature drops below 65 degrees F.

All swimmers must pass the Swim Test, (the "Test": tread water for 60 seconds, and swim one lap of the pool without touching the edge from a standing start in the shallow end), as administered by a Pool Lifeguard, in order to swim in the deep end of the pool. All children who have not passed the Test must remain in the shallow end of the pool under direct supervision of their parent or Guardian.

Children, regardless of their swimming ability, must be under the direct supervision of their parent or Guardian while at the Pool. Children, 12 years of age and older, who have passed the Pool's Swim Test may swim alone in the pool.

No lifeguards are stationed at the wading pool. The wading pool is for parents, infants and toddlers under 4½ years of age. All infants and toddlers under 4½ years of age in the enclosed wading pool area must be under the direct supervision of their parent or Guardian. Older children will be asked to leave the wading pool area.

While on duty, all unnecessary conversations with the Lifeguard(s) or Jr. Lifeguard(s) are prohibited. Lifeguards take their break during the last 15 minutes of every hour. During these breaks there will not be a Lifeguard on duty and all persons under the age of 18, regardless of swimming ability, are required to exit the pool. During the Lifeguard breaks only swimmers over 18 years of age, or those swimmers who are having the Test administered to them, are allowed to swim in the pool.

In keeping with good hygiene, all persons must shower prior to entering the pool (including after the hourly break) and wash their hands after using the bathroom. Shoulder length or longer hair must be tied back or covered by a swim cap while in the pool.

Use of the pool by anyone suffering from fevers, colds, infections, skin disorders or any contagious diseases is prohibited. Please refrain from using the pool for a period of at least 48 hours after recovering from an illness.

All children under the age of three, and any person who is not toilet trained, must wear specially designated non-disposable swimming diapers at all times. The use of a cloth diaper and a plastic diaper cover or disposable swimming diapers are not allowed in either of the pools.

Due to the size of the pool, flotation and aquatic equipment may be used only when approved by a Pool Lifeguard, and when space and safety permit them. When in the pool, non-swimming youths must: (1) wear approved safety flotation devices, (2) remain in the shallow end of the pool, and (3) be within arms reach of their parent or Guardian at all times.

There is to be no running around the perimeter of the pools at any time. NO: diving, foul language, dunking, unnecessary splashing, pushing or other 'rough' play, or spitting within the grounds of the Pool.

Objects that may endanger the safety of the Members, Guests, the Pool or its machinery, are not permitted at the Pool. Eating is permitted on the grass areas only. Absolutely no gum or glass containers are allowed on the concrete perimeter or in the pools. All Members and Guests are requested to place trash and recyclables in the proper containers (blue for garbage, brown for mixed containers).

Please stay off of the lifelines unless required for temporary support.

No animals are allowed at the Pool and all bicycles must be parked in the bike rack.

Please supervise your children when walking through the parking lot. The use of the 'sport court' is at your own risk. The Pool is not responsible for any damaged, lost, stolen, or forgotten articles. A 'lost and found' box will be used to keep unclaimed articles for 30 days.

**GREEN VALLEY PARK AND RECREATION DISTRICT
RELEASE AND ASSUMPTION OF RISK AGREEMENT
AND AUTHORIZATION FOR EMERGENCY TREATMENT AND TRANSPORTATION**

I, the undersigned parent or legal guardian of the family named below, hereby assume full responsibility for all risk of injury or loss which may result from any and all sponsored activities, including but not limited to the Green Valley Pool Swim Lesson Program, the Green Valley Pool Swim Team Program (collectively "Programs"), and other non-sponsored activities at the Green Valley Pool, participated in while at the Green Valley Pool by myself, or any member of my family, or any Guest(s) of my family (collectively "Family") that we bring to the Green Valley Pool, and hereby agree to hold harmless, release and forever discharge the GREEN VALLEY PARK AND RECREATION DISTRICT, ITS OFFICERS, DIRECTORS, AGENTS AND EMPLOYEES (collectively the "District") FROM ANY AND ALL CLAIMS AND DEMANDS WHATSOEVER WHICH THE UNDERSIGNED, AND ANY OF THEM OR ANY THIRD PARTY AND THEIR REPRESENTATIVES OR ANY PERSON ACTING UNDER THEIR BEHALF HAVE, OR MAY HAVE AGAINST THE DISTRICT BY REASON OF ANY ACCIDENT, ILLNESS, INJURY, OR DEATH TO ANY PERSON OR PERSONS, OR DAMAGE TO, LOSS OR DESTRUCTION OF PROPERTY ARISING OR RESULTING DIRECTLY OR INDIRECTLY FROM MY "FAMILY'S" PARTICIPATION IN THE AFOREMENTIONED PROGRAMS OR NON-SPONSORED ACTIVITIES, AND OCCURRING DURING SAID PARTICIPATION, OR SUBSEQUENT THERETO REGARDLESS OF WHETHER SAID CLAIMS OR DEMANDS ARISE OUT OF NEGLIGENCE ON THE PART OF THE DISTRICT. THE TERMS OF THIS RELEASE SHALL SERVE AS A RELEASE AND ASSUMPTION OF RISK FOR MYSELF, MY FAMILY, OUR GUESTS, HEIRS AND EXECUTIVES, understand, acknowledge and agree that swimming, and participating in Programs and non-sponsored activities in and around a swimming pool, is potentially hazardous and may include physical and/or strenuous activity. I fully realize the dangers of participating in these kinds of activities and hereby assume all risks including, by way of example, and not limitation, the following: the dangers of personal injury, death by drowning, property damage; and the released parties' own negligence. I hereby assume all risks of such activities. Understanding this, I state, to the best of my knowledge, that I or any member of my Family, have no medical, physical, mental, or emotional health conditions which would hinder myself or any member of my Family's participation in the Programs or non-sponsored activities.

In the case of an emergency in which I am not able to give permission for medical treatment and my designated emergency contact(s) cannot be reached, I authorize the employees, staff or agents of the District to obtain whatever medical treatment is deemed necessary for myself or any member of my family, or Guests of my family, necessary for their welfare. In case of any of my children this authorization is given pursuant to the provisions of Section of the Family Code of California. I further understand and agree that I will be financially responsible for all charges and fees incurred in the rendering of said medical treatment, regardless of whether my medical insurance would cover such charges and fees.
